### Agenda To Include Board Elections, TRAC Report, State Senate Update

Our community meeting will open with an update on the Cubs expansions issues (for additional information on this topic, see article below. A neighbor will then be discussing a serious prostitution problem, and presenting an action plan (for more information, see article, page 3.)

State Senator Lisa Madigan will present a review of the recent legislative session in Springfield. This will be followed by a short presentation from Barb Head, president of the Tax Reform Action Coalition, who will provide an update of TRAC's progress with elected officials and other grassroots organizations, and membership recruitment. She will provide a plan for this autumn's mobilization efforts that will coincide with the receipt of our revolting tax bills!

In addition, SNA board elections will be held (see article on page 3) and a report on the recently held Garden Walk will be given.

On August 21, the first meeting of the Cubs Blue Ribbon Committee was held at the Stadium Club in Wrigley Field. The meeting was attended by Aldermen Hansen, Schiller and Schuller, representatives of all surrounding neighborhood organizations, the City and the Cubs. ## Notes From Our July Community Meeting

In our July Southport Neighbors Community Meeting at the Mercury Theater, three major pieces of neighborhood business were addressed: 1) permit parking; 2) Cubs expansion plans; 3) development and zoning — specifically, educating neighbors on how to assess new development and compliance with permits/zoning regulations.

On the first issue, SNA brought forward the results from our recent survey in which many residents reported dissatisfaction with the current permit parking system and/or lack of enforcement. After much discussion in which President Jacki Davidoff offered the possibility of repealing permit parking, residents expressed the view that they liked the system in place, but were extremely dissatisfied with the lack of enforcement. Some neighbors spoke about 10-20 cars in their alleys during Cubs games (particularly those close to the ball park) and others about lack of police action on calls to 3-1-1. Consensus was to be more vocal with the police and the Alderman about the system being "broken". It was agreed that both parties need to hear from us about how enforcement must be stepped up. One way to do this is to attend the CAPS meetings (Community Policing) which are now held directly before SNA community meetings at the Mercury Theater, 7-7:30 pm. Another way to vocalize your feelings is to contact Alderman Hansen. The phone number for his office is 549-4000.

A discussion of the Cubs expansion issue followed, and concerns were aired about proposed additional night games. A small group of neighbors agreed to convene at a later date to create a proposal for the Cubs on how to be a better neighbor. This did occur, and the proposal was presented at a LVCC/Cubs meeting later in July. *The Cubs planning is far from complete—if you are interested in continuing to provide input, please attend the September meeting, or at the very least, contact SNA about being placed on our email list!*

Finally, Amy Berka and Peter Manis, Planning & Development committee members, discussed how everyone can be a watchdog for new building zoning violations. They distributed the current zoning allowances, and suggested a call to 311 for any violations seen occurring.

Vandalism of cars and property around the taverns that cater to these miscreants is a common problem. The alleys next to our houses play host to illegal activity.

At our upcoming community meeting on Monday, September 24, we will have a petition you can sign to let our local politicians and police force know that this is an issue of great concern to many. Additional actions will be discussed at the meeting to put an end to this growing problem.

## Restaurant Review

### Bistro Marbuzet

7600 W. Madison, Forest Park

Far away and probably not for the kids, but quite suitable for a romantic evening, I highly recommend Bistro Marbuzet in Forest Park. If you ever went to *Daniel J's*, once on Ashland near Grace, or more recently to *Jack's* or *Atlantique*, and enjoyed your meal there, you will certainly like this new incarnation. It reminds us a lot of *Daniel J's*, with a very similar, upscale, eclectic menu. And, one of the best things about the Bistro is the size: a large, spacious room with a great "art-deco" decor. We never felt crowded or rushed even though every table was taken.

The menu varies from week to week. When we were there I ordered the grilled ahi tuna with wasabi mashed potatoes. The tuna was outstanding, done very rare (at my request). I love wasabi, but I think there was a little too much in the potatoes, though I did succeed in eating them all. I started my meal with the grilled pear, Belgian endive and blue cheese salad. It was excellent. I ended my meal with gelato, which comes in several flavors and was a good finish to my meal: sweet, but not toooo.

My friends had beef and pork, proclaiming them to be excellent. The pork was served with dried fruit compote and was very flavorful. Also on the menu are pasta, chicken and another fish (depending on the market).

I say it's worth the trip to. Phone for reservations (708-368-9090) as it seems to have filled a niche in the western suburbs.



### Big Lill's

1507 W. Balmoral, Chicago

Closer to home and far more casual, is Big Lill's, 1507 W. Balmoral (between Clark and Ashland). In fact, Big Lill's is mostly carry out, except in summer when you can sit outdoors and enjoy the passing crowd (if you sit near Clark St.). It's sorta upscale food in a plastic basket. There is a wide variety of sandwiches and salads, all made as you hang around the cash register, but that means everything is fresh and doesn't get cold while your waiter takes care of someone else. If you're a vegetarian, Boca burgers are available and kettle chips are served with all sandwiches. No need to make a reservation or find a sitter for the kids. Pick it up or bring the kids and sit outside; they can't wreck anything!
