





## SNA Develops a Retail Committee

Over the past year, the Southport Neighbors Association (SNA) has been working on developing a *Retail Committee* whose mission is to help positively maintain and grow the diverse retail, dining and entertainment establishments within the SNA boundaries. The Committee's mission is to also provide guidance and direction into the needs and desires of the residents of Lakeview, and to ensure a unique and economically viable, pedestrian friendly commercial district. In order to achieve its mission, the *Retail Committee* would need to be a conduit between the property owners, businesses, Aldermen and the Chamber of Commerce. During the past several months, the *Retail Committee* has begun to do just that by meeting regularly with Ald. Tunney, *Lakeview Chamber of Commerce*, an area real estate broker and a local business owner.

The group has met a few times this year and has addressed a number of items, one of which was the proposed Jewel-Osco store's remodeling. Unfortunately, with the recent purchase of Albertson's (Jewel-Osco stores parent company) by Super-Valu, the remodeling plans have been suspended. The *Retail Committee* will continue to keep tabs on the new owner's remodeling plans and hopes to participate in the development of those plans. A success story for our Southport retail (albeit, outside of the SNA boundaries) that was announced at one of our *Retail*



*Committee* meetings is the arrival of an Anthropologie store in the former Carpet One space. This will be an addition to our shopping district that will further enhance the retail offerings and brings a national brand name to Southport!

The Retail group meets every six weeks or so in the Alderman's office. Any retailer, financial institution, or commercial properties owner or realtor is invited to attend. # TunneyTalk

Spring 2006 44th Ward

We made it through another Chicago winter, although it wasn't so bad. Now we can start looking forward to sidewalk cafes (which can begin March 1st), the *Cubs Baseball Season* (first home game is April 7th), street fests and other events that make spring and summer in Chicago awesome.

### SUMMER FESTIVAL SEASON

All of the regular 2-day festivals are returning to Lakeview and our office is processing applications for block parties around the ward. The Cubs Charities "Race to Wrigley" 5K run is set for April 15th from 8am-10am on several streets surrounding the ballpark to the north.

Chicago will host *Gay Games VII* from July 15-22 of which our ward will play host to the sailing competition at Belmont Harbor, the marathon event along the lakefront path, and closing ceremonies at Wrigley Field. We are proud to join the rest of the city in welcoming over 12,000 athletes and 20,000 spectators to our beautiful part of the city.

### GREEN ENVIRONMENT

We continue to push for the use of bicycles as the alternative to gas guzzling cars. New for 2006, the city installed several new directional signs marking bike paths and distances. Also, bike lanes will be installed on Clark Street from Diversey to Irving Park Road. *Bike the Drive* is scheduled for May 28th. As in previous years, Lake Shore Drive will be closed to cars from 5am-10am.

A priority for our office is to improve and add greenspace. This summer, improvements will be made to the playground of Belmont Harbor at Roscoe. New campus parks are slated for Blaine and LeMoyné Inter-American Magnet Schools.

Additionally, we have been working closely with the *Bureau of Forestry* to replace dead trees and add

new ones to several locations in the ward. An extensive tree trimming took place this past winter to help ensure the health of our mature trees and improve the public safety on our streets.

### CRIME AND PUBLIC SAFETY

My office remains focused on deterring and preventing crime in the neighborhoods. This season we have worked closely with businesses and community groups to address hot spots and incidents. We encourage all residents to become active in the CAPS (*Community Alternative Policing Strategy*) beat meetings and to get to know the officers patrolling your streets. ### OUR SENIOR CITIZENS

The *44th Ward Senior Advisory Council* continues to bring information and resources to seniors in the ward through its representatives. The council is currently placing seniors in tutoring positions in our ward's schools. If you are or know of a senior who is interested in helping in the schools, contact Christine Brown, *44th Ward Senior Services Coordinator*. This year's *Senior Resource Fair* will be July 13th, held at Illinois Masonic Hospital.

### PARKING PERMITS

*Cubs Night Game Parking Permits* have been mailed by the Department of Revenue. Residents whom have not received parking permits in the mail or are new to the community may pick them up at my service office, **1057 W. Belmont**. In order to obtain permits, please provide the following information: Proof of Residence, Photo ID and Chicago Vehicle Sticker Receipt. Eligible residents will receive **1 Annual Sticker + 2 Single Game Guest Passes**.

### UNDER CONSTRUCTION

With the mild winter, construction didn't slowed down much, but spring does usually bring with it more construction work, both private and public. If you have any questions or concerns about construction projects, please feel free to contact our office.

The CTA is well underway with the Brown Line Reconstruction project. They have begun some station closures in other wards and have begun working on the Belmont Station. The Diversey, Wellington and Southport Stations are scheduled for some closures during their rehabilitation, but that isn't anticipated before late summer or early fall. Our office continues to meet with the CTA, other elected officials and the community through the monthly *Brown Line Task Force* meetings. The *Department of Transportation* has replaced about 250 faded or damaged signs throughout our ward. Numerous crosswalks have been repainted with more as the weather improves. Residents interested in having their sidewalks replaced should contact our office to participate in the *Shared-Cost Sidewalk Program*.

**CAPS MEETINGS**

**Chicago Alternative Policing Strategy**

Meet the officers who patrol your beat. Work with your beat officers and your neighbors to determine the priority crime problems in your neighborhood. Find out what the police are doing — and what you can do — to fight crime and address the priority problems on your block and your beat. Meet your neighbors and get organized. You can do all of these, and more, at your beat community meeting.



Beat community meetings are hosted by the Police Department and are chaired by a police officer who is a member of the beat team. A member of the community, often called a beat facilitator, may co-chair the meeting and assist in establishing the agenda.

Beat community meetings are an important first step in the CAPS prob-

lem-solving process on your beat. The meetings provide you with the opportunity to help set the crime-fighting priorities in your community — to work with your beat officers in identifying and prioritizing crime and disorder problems, in analyzing those problems, and in developing strategies to address them.

Information from the beat community meeting is used by the beat team in creating the beat plan — a tool that helps police officers and the community keep track of the priority problems on the beat and the progress made in addressing those problems.

*Directed Development Council* (CDDC) has been meeting monthly to develop a strategic plan for the 44th Ward. The Council is in the final stages of preparing a draft strategic plan which will then be submitted to the entire Lakeview Community for review and approval.

The CDDC also serves as the Alderman's forum to announce significant development in the ward. Recently, the Alderman announced that the *Wrigley Rooftop Ordinance* passed the City Council with 3 amendments added. The ordinance itself allows the rooftop owners surrounding Wrigley Field to expand the height of their buildings to 61 feet if the property is located from Kenmore to the right field pole, and 63 feet if it's located outside of the foul lines. The ordinance does preserve the existing façades while requiring significant upgrades for those that add on to bring their buildings up to acceptable safety standards. At present, there are 13 rooftop venues, with two more to be developed. Ald. Tunney reported

that due to the cost, many may not expand but at least 5 of the buildings will definitely build up which adds at least 300-500 additional fans on top of 1,800 new bleacher seats. SNA has expressed concern that this is piling on to problems residents already face with scarce parking, drunken disorderly conduct, and public safety.

Another announced large scale project in our area is the property at Clark and Belmont and the St. Luke's property at Greenview and Melrose. Centrum Properties (perhaps in conjunction with LaSalle Bank) proposes to build a mixed use project with two floors of retail space and another five floors of residential space for a total of seven stories. The structure at its highest point will be 85 feet tall. The development calls for 400 parking spaces. The development will include a drive thru for LaSalle bank with the lanes exiting out onto Melrose. This development is similar in scale to the development on the south side of North Avenue near Sheffield that includes the Crunch Gym, California Pizza Kitchen and Jamba Juice. The obvious concern for residents is the traffic and congestion this will create

for Belmont, Lincoln and Ashland which already experiences heavy traffic. Before the project develops further, a traffic study is to be performed. As a separate project, Saint Luke's proposes to build a senior supported living center with (over 100?) rooms and 138 parking spaces. The building will have five floors with the fifth floor recessed from the fourth floor.

Finally, Ald. Tunney is again reviewing the impact of the 2004 *Chicago Zoning Code* on all neighborhoods in the ward to determine if it meets the needs of the community or if rezoning is needed. While there are still overdevelopment issues, in our area, with loss of green space, breezeways and the teardown of one beautiful greystone, the new Zoning Code appears to be working in the SNA area. However, SNA plans to reconvene its *Preservation Committee* to study the need to further protect the CDDC meetings are held on the 4th Wednesday of every month. 
## March CAPS Meeting

CAPS is the *Chicago Alternative Policing Strategy*. Every other month a group of police officers that serves your neighborhood meets with the community to provide information and answer questions regarding your safety. BEAT #1923 includes the area bordered by Damen, Clark, Berseau and Cornelia.

At the most recent meeting on March 14th, a number of residents from the 1800 block of Warner attended to bring attention to a number of crimes that have occurred in their neighborhood. Although seemingly unrelated, neighbors reported a rash of thefts ranging from kid's bikes to packages left on porches and even a house burglary. The police officers

emphasized the importance of reporting all crimes, no matter how petty. By reporting crimes, police can identify patterns and affected areas, and then increase their patrol of these areas. The officers also stressed the importance of registering bikes, stereo equipment and laptops. Registered items can often be recovered through pawnshops. Given the large number of 1800 Warner residents present at the meeting, the police officers committed to pay particular attention to their block in the upcoming weeks.

There are plans to have



a special presentation on Theft Prevention at the next CAPS meeting in May. Please try to attend these meetings and help inform the police officers what is happening in your neighborhood! CAPS meetings are held at 4100 N. Greenview (Lakeshore Baptist Church, north of Lakeview H. S.) at 7pm on the second Tuesday of the month. They generally last less than one hour. Our District Community Policing Office number is **312.744.5574**. This is a wonderful opportunity to voice your concerns about safety in your neighborhood.




