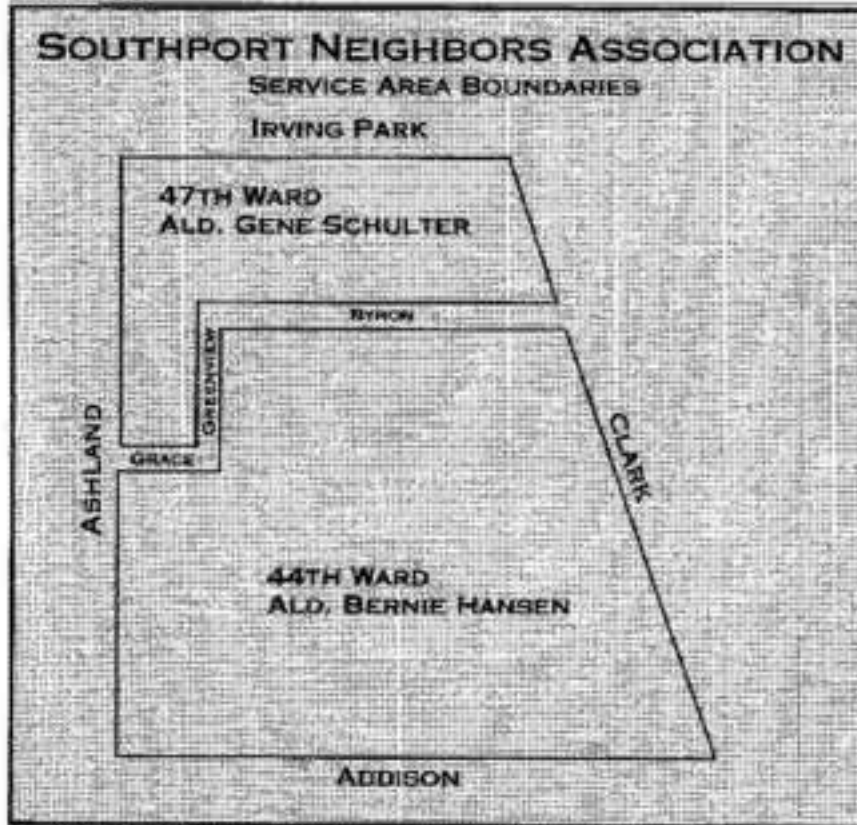

SNA To Participate in Lakeview Community Network

The Lakeview Community Network was formed as a coalition of resident and business groups. Its sole purpose is to help obtain and share information among member groups on quality-of-life issues that affect the greater Lakeview community.

The first quality-of-life issue the Community Network will face is development. They have created a standard checklist for developers who seek the support of a Network member on a development pro-

posal. Many projects have a "ripple effect" which extends across community boundaries into adjoining areas. By joining together, the right questions will be asked early on in the project and member groups will get early notice of developments which may affect them. Other quality-of-life issues to be addressed in the future may include schools, transportation, traffic, parking, infrastructure, safety and crime, parks, and community diversity.

Zoning Update

3845 N. Ashland

The 15-unit building has been topped out. It presents an attractive courtyard facade to Ashland Ave. Our review efforts that resulted in the height being reduced from 5 floors to 4 have certainly paid off.

3918-24 N. Southport

The old buildings have been demolished. The foundation walls have been poured for the two new 8-unit buildings.

3842 N. Lakewood and 3827 N. Wayne

Construction has reached the 3rd floor level of these three-story, two-unit buildings. They appear to meet the requirements of the Special Conservation District.

3939-41 N. Greenview

A demolition permit has been issued for these properties. We have received no information on what will be built there. Within the past two months, the developer has been cited by the Building Department and fined twice by Streets and Sanitation due to the condition of the property.

12-Unit Townhouse Proposed for Wayne

A proposal for twelve townhouses at 3923-33 N. Wayne is under review by the SNA Planning & Development Committee.

The project will be developed by Access Realty Group, 3738 N. Southport, which is owned by Bill Platt, a neighborhood resident (Platt is running for the SNA board of directors at the June 24 meeting). The architect is WRZ Design Group.

Plans call for two buff-colored brick and limestone six-unit buildings facing a center court, with 24 enclosed parking spaces. The buildings will meet the height & density requirements of the Special Conservation District, although not required to because it is not within the covered territory. The builders are requesting zoning exceptions for the depth of the front and rear yards. The developer will make a proposal at the June 24 meeting.

Uptown Recycling Offers New Reuse Programs

Uptown Recycling (UR), who for several years worked with SNA to provide curbside recycling service to the community, has established a new "reuse program" to collect and redistribute reusable goods which are no longer of use to the present owner. Working with a number of northside social service agencies, UR's Urban Resource Warehouse program will also provide work training and job opportunities for people in the community.

UR would be happy to provide free pick-up of your reusable household goods. Collected items are to be

reused and thus, at the present time must be in decent and usable condition. Acceptable items include: household items (furniture, kitchen utensils); equipment (furnishings, typewriters); appliances and tools (indoor and outdoor); and building materials (cabinets, hardware). UR reserves the right to decline certain items at the time of collection. UR is a charitable organization, and thus donations may be tax deductible.

Center. They have an existing store at Halsted and Waveland, which will remain open. Rezoning of the 3939 N. Ashland property would be required.

The other element in this puzzle is the temporary library. The Chicago Public Library Facilities Committee voted on June 11 to recommend the 3939 N. Ashland building as a home for a 2500 square-foot tem-

porary library. The Chicago Public Library Board is expected to accept this recommendation at its June 17 meeting. However, building owner Frank Freedman does not want to tie the rezoning for the resale shop to the library proposal, as he did at the April meeting when the auto parts store was under consideration.

A complete proposal will be made at the June 24 meeting, and the community will have an opportunity to voice its concerns.
