Notes From Our January Community Meeting



Neighbors Vote "NO" on Waveland Avenue Issue

SNA's regular January meeting was held on February 4, due to scheduling challenges related to Presidents Day in late January. The meeting convened at 7:35 with over 75 people present. The main topic on the agenda was the proposal to convert Waveland Avenue to a one-way west between Southport and Ashland Avenues. Also on the agenda was an introduction to this year's children's concert, for which planning is now under way.

The public was notified of the Waveland proposal via the newsletter, found in various businesses along the main thoroughfares in our neighborhood, and via door-to-door delivery of flyers. Proof of residence within SNA's boundaries was required in order to vote on the issue. Sally McPherrin and Jill Peters, residents of the neighborhood, researched the proposal and presented it to the community. Central to the issue was safety around the Juniper Park Playlot, which Sally and Jill felt could be addressed with the change in traffic flow.

The proposal to convert Waveland to a one-way street was defeated by a margin of 55-19. Comments FOR the proposal centered mostly around the desire to keep kids safe around the park, and to perform a traffic study to determine if a one-way would accomplish this. Comments AGAINST the proposal ranged from concerns that a one-way street could speed up traffic, posing further danger to kids, to general concerns about the difficulty in navigating the neighborhood if restricted to traveling west on Waveland. The manager of Jewel Foods was present, and noted that the one-way conversion would force about 15 semi-trucks per week to travel west on Waveland, past Juniper Park. These trucks currently exit the alley behind Jewel onto Waveland, traveling east to Southport, a more appropriate route.

While some at the meeting did not think there was a safety issue at Juniper Park, many others raised alternative safety ideas during the lively discussion. Traffic calmers (speed humps) at the intersection, better signage, parking restrictions near the park, and increased police presence to ticket those running the stop sign, were all mentioned. Alderman Hansen has suggested we investigate the statistics on ticketing at this intersection, in order to gauge the safety issue. The SNA board is considering these ideas. Our children can never be too safe!

Jacki Davidoff introduced the 2nd annual Children's Concert to the community. Planning is underway for the spring event. Last year's event was a huge success, and a great time was had by all. The money raised last year and this year will benefit the landscaping of the newly redeveloped Juniper Park Playlot. Jacki is asking for volunteers to help make this event a success. SNA Planning & Development's *Did you know?*

If your neighbor is constructing an addition or new house, and the excavation for the new structure is within 5 feet of your house, the City of Chicago requires your neighbor to protect the structure of your house "to prevent sagging, settling, cracking or collapse of its foundation and walls."

Your neighbor is responsible for the cost of the reinforcement or bracing, and is required to provide you notice, in writing, 30 days prior to the start of excavation. This notice should include the anticipated starting date as well as the three dimensional measurement of the planned excavation work.

The Excavation Ordinance clearly states:

"The owner of the property where excavation takes place and the person performing the work shall be jointly and severally liable for any damage, death or injury caused by sagging, settling, cracking or collapse of the public way or of the foundation or walls of a structure located within five feet of the excavation, due to absent or insufficient reinforcement or bracing."

"Any person who performs or authorizes excavation work in violation of this chapter shall be subject to a fine of not less than \$500 and not more than \$1,000 for each offense. Each day of a continuing violation shall constitute a separate and distinct offense."

Restaurant Review

Otro Mas

3651 N. Southport Ave.

Otro Mas is an upscale Latin restaurant with a wide variety of creative dishes on the menu. Dimly lit and conversation friendly, it's a great place for a date, or for a nice evening out with friends. Occupying two floors of what apparently used to be an old house, there is a bar and some dining tables on the main floor, with more tables and a lounge area on the upper floor.

The service was friendly and quick, though on a previous visit when most of the tables were full, our waiter did seem to disappear for long periods of time. When dining on the upper floor as we were, the wait staff has to trudge up and down the stairs for bar drinks, which seemed to take some time.

This diner chose the Cabrales for starters, which consisted of mesclun greens, apples, Spanish cabrales cheese (much like bleu cheese) and almonds, with a sherry vinaigrette. The greens were crispy and the salad was very tasty. My dining companion (a.k.a. husband) chose the Tamale, with shrimp, pico de gallo and salsa roja. He really enjoyed it, calling it a "nice twist" on a traditional tamale.

For our main courses, we chose the Lombo and the Carne. The Lombo is a chili cured pork tenderloin served with white beans and a "truffle scented jus." It was a nicely seasoned, good cut of lean meat, firm yet tender, and the white beans were a nice complement. The Carne, a New York strip steak, was served with cabrales mash (potatoes with cabrales cheese), chipotle-confit butter and tobacco onions (much like lightly-breaded onion rings) ...NOT for the calorie conscious, but oh-so delicious! The steak was done to perfection, and the chipotle flavor that infused the potatoes and onions added just the right amount of heat. It made you sit up and take notice, but didn't leave you gasping for cold water.

The crème brulee we shared for dessert was smooth and delicious, made with dark chocolate custard and espresso with a buttery crust. Overall we had a great dining experience with interesting, delicious food. Salad and appetizer prices range from \$5 to \$9 and entrée prices range from \$16 to \$25. Reservations are accepted, but not necessary.
