## Construction Underway at Wrigley Field

While the Chicago Cubs 2005 season closes, we say "Wait Til Next Year". Well, the 2006 season is already upon us in the SNA neighborhood as the Wrigley Field expansion plans are under way. Construction of about 1,800 additional bleacher seats will begin immediately. After many years of negotiating with the city and the Lakeview neighborhood the Cubs will expand the bleachers and develop the triangular piece of property on the southeast corner of Clark and Waveland. Currently, one lane of traffic is closed along the ballpark on Waveland and Sheffield Avenues, but 2-way traffic is still allowed.

SNA will provide an update of any relevant traffic disruptions and timing of the expansion project as it become available. In the meantime, as we head into the off-season winter months, the transformation of the "new and improved" 2006 Cubs begins.

## Southport Shopping Attracts the Media

Southport has become *the* shopping destination in Chicago. Along side our other well-known shopping neighbor, Wicker Park, Chicago's Southport shopping district was featured in *The Wall Street Journal's*, Saturday/ Sunday, October 1-2, 2005, Travel Section. The article was written to help Chicago shoppers rediscover the enjoyment of shopping in neighborhood, boutique retailers that can offer uniqueness not found in nationwide mega stores such as Macy's, which will, by next year, replace a Chicago icon, Marshall Field's.

In the article, Southport was cited as a location within Chicago where one could find unique boutique shops, as 3 of our wonderful shops were highlighted. **Krista K** has a mix of "new designers" and "perennial favorites" and has "staked out a niche in upscale maternity clothes". Being pregnant never looked so good. Another woman's clothing store high-

lighted in the article was **Red Head Boutique**, which stocks "jewelry and clothes from Chicago designers", but best of all, its owner "has a knack for finding jeans that will fit different body types". This is not a "knack", but a gift, and makes Red Head worth a visit for those of us who have tried on countless jeans with not much luck. Finally, **Fly Paper**, was featured as a store that has "stationary, greeting cards and photo albums that range from quirky to professional". The common theme among all of these neighborhood retailers is not only their uniqueness, but also that they are an exhibit of each individual proprietor's personality.

The article made specific reference to the neighborhood feel of Southport which is especially gratifying. While seeing Chicago traditions such as Marshall Field's yield to the competition, it's satisfying knowing that our neighborhood retailers can capture a portion of that market. We are proud of all the retailers that are

establishing our neighborhood into a strong and vital part of Chicago.

"IN STYLE" MAGAZINE

September's *In Style* featured our Southport Avenue in its "hot blocks" section. It focuses on both the hip, unique boutique atmosphere on Southport, and the celebrity factor – places where celebrities have been spotted shopping in the neighborhood. Eight retailers are featured in the article, including **Krista K, Trousseau, Freesia** and **Red Head**, where Jessica Simpson reportedly shops for the "bohemian jeans and tops." In addition, **Splendor** is described as having "retro flair, even when it comes to modern pieces like patterned iPod cases." **Beansprout** is touted as having "cool kids clothes" and **Shane** is reported to have "chic staples."

The article states "Michigan Avenue and Oak Street, step aside. Picturesque little Southport first earned its stripes with great restaurants and bars. High-end boutiques soon followed — and celebrities weren't far behind."

## Ban on Restaurant Smoking Proposed

About 60 people attended a forum last month at the Mercury Theater sponsored by the Lake View Citizens Council (LVCC) to discuss the recently proposed ordinance to ban smoking in restaurants and bars in Chicago, following similar bans in New York, California, Minnesota, and the entire countries of Ireland and Italy.

Alderman Ed Smith was there to outline his proposal and the reasons behind it. Alderman Tunney stood in for the Illinois Restaurant Association to present a different version of the ordinance, also being considered. Also on hand was a representative from the American Cancer Society, a local doctor, a cancer patient and a local bar owner.

Ed Smith's proposal is a complete smoking ban, similar to the ones in the areas listed above. The second version of the ordinance, endorsed by

the Illinois Restaurant Association, was introduced by Aldermen Natarus and Coleman. They propose that restaurants and bars be allowed to get a license to allow smoking, instead of banning it altogether. The American Cancer Society representative supported Alderman Smith's complete ban, stating that the alternate proposal would be akin to allowing people to get licenses to use their handheld cell phone devices when driving, after it has been outlawed for Chicagoans as a whole.

Proponents of the ban went beyond patrons of the establishments to the plight of waiters and others forced to be in a smoky environment while working. There was a big focus on the workers inside smoking establishments, and Mary Rondoni was there to talk about her experience as a stage 4 throat cancer victim. She is

currently appearing in television ads as a supporter of the smoking ban. Ms. Ron-doni was told by her doctors that her throat cancer was almost certainly caused by the second-hand smoke that she breathed at work every day at a Chicago restaurant.

Overall, most in attendance seemed to favor the complete smoking ban. They were told that revenue and customer numbers have not fallen in establishments where a ban was already in effect. And they did not seem to favor the licensing idea, since it would defeat the purpose of the ban.

If you support the smoking ban, call your alderman and say so. And if you don't support it, call and say so. It's the only way the alderman will know how his constituents feel. Be sure to be specific though – if you support the complete ban, make sure you say that you are supporting Ed Smith's proposed ordinance.

Autumn 2005 44th Ward

Another losing Cubs baseball season is over, the chill in the air is back, sidewalk cafés are packing up their chairs and children are in school. Now it's time to start thinking of snow.

As always our office appreciates feedback from constituents on neighborhood events as it assists with planning and logistics for the coming year.

### LABOR DAY WEEKEND 2005

A first time ever music performance took place in Wrigley Field. Jimmy Buffett played to two sold out shows amid a sea of parrotheads and grass skirts. All the regular neighborhood protections were in place along with additional security by the police and the Cubs. Issues of noise and congestion were fairly limited and there were no major arrests. Chicago Cubs Charities made a donation of \$150,000 to our local schools which will be distributed among the schools in the four wards affected by Wrigley.

### ISSUE OF CRIME

As fall approaches the presence of crime in our neighborhood generally cools down with the weather. However, it's important to continue to stay on top of all activity in your neighborhood. CAPS (*Community Alternative Policing Strategy*) has created several initiatives that promote awareness, protection, and safety. The CAPS beat meeting schedules can be found on our website at [www.44thWard.org](http://www.44thWard.org). CAPS beat meetings are a great place where residents can learn about issues

critical to their district, meet and talk to their local police officers, and learn how to better protect themselves. All residents are encouraged to attend.

### SENIORS

The 44th Ward Senior Advisory Council hosted the annual Senior Awareness Day and Senior Picnic in August with over 300 seniors participating in both events. The council is currently working on a tutoring program for local schools and on planning events. ### PARKING PERMITS

The necessity for LV2 (Cubs Night Game) parking permits is over for 2005, but Residential Permit Parking Stickers are still required in all 383 coded parking areas, and city stickers are required on all cars kept in the city for more than 30 days. Effective January 1, 2006 the City Clerk will no longer have satellite offices at 5401 N. Elston and 9901 S. Cicero. City stickers and residential stickers will be available at City Hall (121 N. LaSalle). City stickers may also be purchased at 2550 W. Addison or at currency exchanges. The Winter Parking Ban begins on December 1st. Please carefully read the signs posted on the main arteries to ensure that you are not in violation of parking restrictions.

### STREET CLEANING

The schedule through the end of November is posted on our website, [www.44thWard.Org](http://www.44thWard.Org). The streets will continue to be cleaned weather per-

mitting throughout 2005. During the month of December, the cleaning schedule will be determined week to week. Contact the Department of Streets&Sanitation at **312.744.5028** for the schedule during December. In addition, they have asked that you *not* put raked leaves in the street. Please place them in blue bags and dispose of them in your garbage carts. Also, make sure that the sewer covers in front of your home are clean and free of debris to ensure proper water flow to avoid possible flooding.

### RENOVATION OF WRIGLEY FIELD

The Chicago Cubs organization has begun renovation of the bleachers. Sidewalks beside Wrigley Field will be closed to pedestrian traffic for the duration. This affects the west side of Sheffield and the south side of Waveland. In addition, there will be no parking on Sheffield from Addison to Waveland or on Waveland from Sheffield to Seminary. The Cubs will make available free parking for residents of these blocks in the Cubs' Blue Lot (Waveland just west of the Fire Station). Residents choosing to use the Blue Lot *must obtain a Blue Lot Sticker* from my office. Proof of residence, photo ID, and city sticker receipt are required. In addition, the West curb lane of Sheffield and South curb lane of Waveland will be closed during construction. Traffic on the affected

streets will continue two lanes—one in each direction.

**CTA'S BROWN LINE RECONSTRUCTION**

Our Diversey, Wellington, Southport and Paulina 'L' stops will be closed for anywhere up to a year as they are each being worked on. *No two adjacent stations will be closed at the same time. The Belmont station will not be closed at any time.* The CTA has already acquired most of the properties and most of them have already been demolished. My office continues to meet with the CTA, other elected officials and the com-



munity through the Brown Line Task Force to discuss how to best mitigate these upcoming CTA challenges.

**ZONING & DEVELOPMENT**

The 44th Ward Community Directed Development Council (CDDC) continues to meet monthly to discuss ongoing zoning and development issues and to continue to develop the 44th Ward Master Plan. The CDDC (*Community Directed Development Council*) has been meeting monthly with the Alderman to develop a strategic plan for the 44th Ward. The Council has prepared a draft plan which is undergoing edits for final publication by the end of the year following community input.

At the September meeting of the CDDC, the Wrigley Rooftop Owners Association presented their plans to increase the height of at least 5 of the 13 properties having a view of Wrigley Field. With the Cubs expansion plan underway, the roof top owners have requested a height increase of up to 8 feet to raise their viewing area above the new site lines.

However, the plan entails upzoning all of these 13 properties from largely residential zoning (a couple are already zoned for mixed business & residential use) to business zoning with a covenant requiring them to downzone to residential upon completion of their plans. The Association claims the need to upzone in order to add elevators, safety features, and

ADA requirements to their expansion plans. The result of this change will likely raise the heights of these buildings from 61' to 71' (including elevator shafts), cause the buildings to fill most of the lot, and increase the number of patrons viewing from rooftops by several hundred in total.

The plan was challenged by SNA, who asked that the rooftop owners limit their seating to the actual (or published) number of patrons that can currently occupy the viewing areas rather than the posted occupancy rates. SNA's investigation of the capacity issue revealed that the actual viewing number is less than the posted occupancy number. Unless the owners hold to their current published numbers, the expansion plans will allow these building owners to maximize their occupancy rates, which means at least 25-50 more patrons per building. That number adds to the 1800 additional fans the Cubs are allowed. There are 400 additional seats coming in the form of brand new rooftops, and the upzoning will likely provide enough incentive for the billboard buildings to convert to rooftop seat-

ing, adding yet another 400 patrons to each game. If you do the math, counting the Cubs' expansion, new rooftops, the potential for more new rooftops, **and** the increased capacity in current rooftops, our neighborhood could experience a total of over 3000 more fans in the next 1-2 seasons. This, after the neighborhood spent 4 years investing our time in the Blue Ribbon Committee, which pared the Cubs' expansion down by 600 seats.

## Greystone Demolished Good Bye 3733 North Lakewood

The greystone at 3733 N. Lakewood was recently torn down, despite exhaustive efforts by SNA and many residents to save the building. The owner, Mike Joyce, whose business is located in Elmhurst, bought this property as a tear down to maximize the lot area and build an expensive spec home a couple of feet wider than the existing structure.



this beautiful building. We received over 300 signatures from area residents on a petition circulated to save the property, which was forwarded to

the Alderman and the builder. We also spoke to the Alderman, the owner, and builder general contractor, Mangan Builders, to determine ways to save this greystone. The Alderman also met with them separately on several occasions.

Additionally, with support from SNA, residents on the affected block met with

Jonathan Fine of Preservation Chicago who advised that the 3700 block with its rows of greystones on

30' wide lots, was unique and could qualify for landmark status. Landmarking is one solution that protects the essential character of the block, but still allows significant additions and modifications to be built. Unfortunately, we did not have enough time to organize this approach, as the developers were ready to maximize their investment by getting this new building started. The compromise that was reached between the alderman and the developers was this: the design of the building will be appropriate for the historic nature of the block. The developers will be working with Brian Goeken from the Landmarks Division of Chicago on the exterior details that will make the building look historically accurate. This was not the neighbors' first

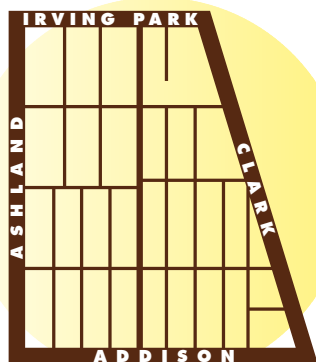
