# Concert *Wrap Up*

The Police played two concerts at Wrigley Field on July 5<sup>th</sup> and 6<sup>th</sup> from 7pm until 10:30 p.m. As President of SNA, I made a point of walking through the neighborhood both nights. I was joined by Mike Lufrano from the Cubs and Alderman Tunney. The crowd was mature and respectful to the community.

As a result of SNA's early concerns about concerts in our neighborhood, the Cubs hired 30 private security officers to address area problems. Additionally, at our request they placed portable potties in every alley within our boundaries. Further, the City assigned a significant police force to the concert patrol and a few remained on duty long after the concert ended.

We received a few complaints about noise from the concert and about news helicopters flying overhead early in the morning and late at night, and about noise from Clark Street late into the night. The Alderman, the Cubs and I all addressed this concern by contacting the new stations who agreed not to fly overhead the second night. Additionally, there were reported parking violations and as expected several illegal fireworks. We do not have all the police data from the events as of this writing, nor have we received any noise level reports.

During the concert, Clark Street was heavily congested surrounding Wrigley, and people packed into some of the sidewalk bar cafes. Most of the revelers left before 1:30a.m. on Thursday night, but the crowd on Clark Street was noisy well past 1:30 a.m. on Friday. The Community Policing Office confirmed that it was louder than usual that night. During the Jimmy Buffet concerts we received many complaints about public drinking. However, the Police attracted a very different crowd and there was very little public drinking. The Cubs have donated \$150,000 as their contribution from the concerts to the four affected wards surrounding Wrigley. Immediately following the concerts, the Lake View Citizen's Council ("LVCC") President, David Winner went public with his proposed 5 year plan for future concerts. By way of background, The LVCC was asked to forfeit their Music festival on Sheffield to allow this year's concert at Wrigley. For this inconvenience they received \$25,000 from the Cubs and an agreement to host a

fundraiser for the organization at Wrigley Field this July 27<sup>th</sup>. LVCC's proposal would include some of the same but not all of the neighborhood protections SNA requested this year, and the proposal ensures that the Cubs do similar fundraising activities for LVCC each of the 5 years in exchange for permanently giving up its festival on Sheffield. However, they were able to host a one day fest this year on Ashland Avenue on July 7<sup>th</sup>. The plan asks for community money from the Cubs each year to be spent upon LVCC's direction.

The SNA Board opposed LVCC's five year plan which was initially proposed before the concerts with only standard night game protections, because after polling our community about hosting another concert this year, it became apparent that half of our community opposed any concerts. The LVCC 5 year plan proposes to give the LVCC input, as the one voice for all 12 neighborhood groups in the 44<sup>th</sup> Ward.

We appreciate that both Mike Lufrano of the Cubs and Alderman Tunney have listened and have been extremely sensitive and responsive to SNA's concerns. The concert ordinance that was passed included the protections we requested. LVCC has only adopted some of these. The Alderman has also expressed concern about committing to a five year plan especially because of the uncertain ownership and future of the Cubs organization which is also of concern to SNA. The chosen band and chosen concert days each year bring new challenges, SNA believes we should continue to have input each year (as we are one of the most affected communities) to be sure the care and attention the Cubs give to our neighborhood security and other issues. Authorizing LVCC's 5 year plan would significantly reduce our protections and yearly input.

## CDDC *UPDATE*

Alderman Tom Tunney's Community Directed Development Council ("CDDC") continues to meet on a monthly basis to discuss large scale development projects in the ward. Recently, the Alderman has formed a subcommittee to discuss long range planning for Wrigley area development to respond to proposed developments with a strategic plan for the area. The subcommittee has completed an inventory of the properties surrounding Wrigley. CDDC meetings are held every fourth Monday at 7:00p.m. of the month at Ann Sather's restaurant. The public is always welcome.
