Third Concert at Wrigley Field Violates Night Game Ordinance

As you should have heard by now, this summer the Cubs have planned to host three concerts in July 2009; two Elton John/Billy Joel concerts on Thursday, July 16th and Tuesday, July 21st, and one concert with the country band Rascal Flatts on Saturday night, July 18th. Their decision to abandon agreements of the past and to host a third concert instead of two as in past years not only violates the spirit and goodwill of the agreements SNA previously negotiated with them, but also violates the Night Game Ordinance which prohibits night games on Saturday nights and limits nighttime events at Wrigley to 30 in a year. Unlike past years, the concerts this year are not on a holiday and the Cubs will not give up an additional night game or make additional donations over and above the \$150,000 they donated in the past to the various schools and charities for two concerts. Despite SNA's efforts to cancel the Saturday night event, Alderman Tunney supported the Ordinance authorizing the three concerts.

SNA objected to the Cubs hosting more than two concerts in any year and particularly opposes a concert on a Saturday night. Clark Street is already very busy on a Saturday night, so adding 40,000 concert-goers will significantly add to traffic, noise, and late-night partying. Because concerts present additional challenges to our community with loud sound checks, helicopters flying overhead at all hours, and street closures during setup and take-down, the disruptions will extend over 7 days on top of the 16 home Cubs games in July.

Our community deserves assurances from the Cubs that the night game ordinance will not be violated again and that the Cubs will give back to the community as they have in the past by giving up two night games in 2010 and by donating more than in past years to the affected community schools and charities.

Saturday Night Concert at Wrigley Forces Cancellation of Summer on Southport this Year!

SNA's Summer on Southport ("SOS") festival featuring the best Children's Festival in the city and great adult musical events, was forced to cancel this summer, due to the Cubs' decision to host a concert on the same night. Summer on Southport is a community-building and fundraising event for our neighbors. This year, like the past 7 years, Summer on Southport had been scheduled for the one weekend in July when the Cubs will be out of town, Saturday and Sunday, July 18th and 19th. Now with the addition of a concert at Wrigley scheduled for the same Saturday night, SNA had to cancel our popular Summer on Southport Festival this year.

SNA was formed to represent the community to address quality-of-life concerns. In the interest of reducing the stress on our residents and businesses on Southport, our Board made the decision that we need to be true to that mission and cancel our festival this year. After exhausting every option to change the date or reduce the scale of our event, and considering the significant economic risks for a small not-for-profit organization, we were left with no viable alternative but to cancel this year with plans to return in July 2010.

While SNA had hoped to donate to our local charities again this year, Blaine School, Sheil Park Playground Renovation, and the Lakeview Pantry, we have been told by Alderman Tunney that he will insist the Cubs make these donations and contribute to the support of our Southport businesses to ensure they succeed in this economy.

CHAPTER VII. - USE OF PARKS

10. Bringing Animals in Park

a. Animals Permitted.

No person owning or being custodian or having control of any animal shall cause or permit such animal to enter or remain on Park District property, except:

(1) Except in areas designated by the General Superintendent as "Dog Friendly Areas", a domestic animal may be brought into a park so long as such animal is continuously restrained by a leash not exceeding six feet in length. Animals may not enter or remain in any building, zoo, playground, harbor, lagoon, swimming pool, spray pool, garden, athletic field, animal or bird refuge, or other areas that may be designated by signs as prohibited areas.

NEIGHBORHOOD HAPPENINGS

Cubs Expand Sidewalk Cafe into Outdoor Club

As reported at the February and March CDDC meetings, and by the Tribune, the Cubs have announced their plans to expand a small sidewalk café at the South entrance of the park, to build a large tented Harry Caray's bar and restaurant to be open year-round—not just on game days—which will operate like a "club" with the possibility of adding live music and other entertainment in the future. The 7,000 square feet of outdoor tented area will take up a significant amount of sidewalk area at the south entrance, which also raises serious concerns about pedestrian safety during game days as well as more noise and congestion on Addison, Clark and Sheffield year-round.

Having only announced their plans at the end of February, the Cubs intend to open the club in time for opening day, April 6th. However, it has not been presented to the affected community groups for approval. SNA has voiced our concerns because Wrigley Field is a planned development and the project should have been vetted through the affected communities with more than 45 days notice before its opening. But the City building code allows construction permits to be issued before the expanded liquor license is approved and notices have only been sent to those residents and businesses within 250' of the project. The club will be housed in three separate tent structures with canvas over steel frames built along the South entrance to the park. The club will leave just 14 feet of sidewalk. It will be open for lunch and dinner until 11pm (Sun-Thurs) and 12am (Fri-Sat). Occupancy is expected to be 300 on non-game days, and 500 on game days. As of this writing, the Bureau of Licensing had not finalized their liquor license expansion.



Clark and Addison Development Update

A large 10-story development with a hotel, residences, and significant retail space at Clark and Addison has been presented to Alderman Tunney's Community Directed Development Council (the "CDDC") for initial screenings. Because this is a planned development (a "PD"), any plan that is seriously considered for a zoning increase must be presented to the Lakeview community groups for approval. This is purely an informational update.



As reported at the January SNA Community Meeting, the various plans that have been proposed thus far have been rejected by the CDDC. A Wrigley Planning Subcommittee was formed which made specific recommendations to the developers to reduce the scale of the project to reflect the current zoning (B3-2 on two thirds of the site and B3-3 on the remaining third of the site). Because the Alderman requested that the subcommittee allow an increase in the zoning to B3-3 and FAR (floor area ratio) to 3.0, the Committee agreed to allow the overall zoning to increase to B3-3 with an FAR of 3.0 and a 71.5' height limit (about 5-6 stories). The Committee also recommended that the property be developed as a hotel, not as a rental apartment building. They also recommended that the height above three stories be set back from the street so as not to tower over other properties in the area, and they strongly discouraged big box retailers such as Best Buy.

Based on the subcommittee's recommendations, the CDDC unanimously adopted the recommendations as a cap or ceiling on what can be built rather than a floor from which further height and bulk can be negotiated. The CDDC unanimously agreed not to make any additional concessions on height, FAR, or zoning allowances. Subsequently, two plans were proposed in December that failed to meet these standards and were again rejected due to height and density issues. While the developer has sent letters to every residence in Lakeview to seek support for the project, no new plans have been proposed since December.


